Additional notes and determinations:

MAMMALS: Base figures from M. A. Steele and G. Kwiecinski, 2005, Mammals of Pennsylvania checklist, with adjustments from recommendations by PABS Mammals Technical Committee.

Details:

State endangered: least shrew, Indiana bat, fox squirrel (Delmarva subspecies only – extirpated?), northern flying squirrel, Allegheny woodrat.

State threatened: water shrew, eastern small-footed myotis, Appalachian cottontail, fisher.

Extinct or extirpated: marten, mountain lion, lynx, rice rat, gray wolf, wolverine, moose, bison.

Non-native and reproducing: thirteen-lined ground squirrel, Norway rat, house mouse.

FUNGI: PACMA records (except for tally of non-natives).
